MINIMUM QUALIFICATIONS FOR APPOINTMENT OF TEACHERS IN COLLEGES AS PER UGC REGULATIONS

ASSISTANT PROFESSOR

**Arts, Humanities, Sciences, social Sciences, Commerce, Education, Languages, law
Journalism and Mass Communication**

- i. Good academic record as defined by the concerned university with atleast 55% of the Marks or equivalent grade where grading system is practiced at the Masters degree level in a relevant subject from an Indian University, or an equivalent degree from an accredited foreign University.
- ii. Besides fulfilling the above qualifications, the candidate should have cleared the National Eligibility Test (NET) conducted by the UGC/CSIR or similar test accredited by the UGC like SLET/SET.
- iii. Notwithstanding anything contained in sub.clauses(i) and (ii) to this clauses 4.4.1, Candidate, who are or have been awarded a Ph.D. degree in accordance with the University Grants Commission (Minimum Standard and procedure for award of Ph.D. degree) Regulations, 2009 shall be exempted from the requirement of the minimum eligibility of NET/SLET/SET for requirement and appointment of Assistant Professor or equivalent position in university/College/In institutions.
- iv. A relaxation of 5% may be provided at the graduate and masters level for the SC/ST/Differentlyabled (Physically and visually handicapped) categories for the purpose of eligibility and for assessing good academic record during direct recruitment to teaching positions, Rounding off of marks to make it to 55% or 50% as the case may be through grace mark procedure etc, by universities is not permissible for claiming relaxation.
